We respectfully request that Mr. Robert Watson recuse himself from participating in the discussion and voting on item 8.B. "Consider amending the Water and Sewer Agreement with Boot Ranch to swap 37 acres (known as Muncey tract). The reason for this request is based on Section 2-204 (C) City of Fredericksburg Ethics rules. It is clearly understood that Mr. Watson owns property in Boot Ranch with a taxable value exceeding \$100,000, in addition to a Boot Ranch Club membership valued at \$100,000, and is a member of the Boot Ranch HOA. Furthermore, Mr. Watson proposed this land swap idea in a City Council meeting and led the ensuing discussion between Boot Ranch and City Council.

A reasonable person would recognize that Mr. Watson's substantial ownership and membership at Boot Ranch would have, and have had, weight in his decisions with respect to Boot Ranch items. Moreover, Mr. Watson's decisions on Boot Ranch items have an economic impact that are clearly distinguishable from the citizens of The City of Fredericksburg, based on his ownership/membership position.
