Submittal Requirements

Drawings submitted need to show the following:	
<input type="checkbox"/>	The location of the proposed sign on the site or the building, including dimensioned references to adjacent building features or nearest property line as appropriate.
<input type="checkbox"/>	Dimensions of the sign and sign structures, including foundation and mounting details
<input type="checkbox"/>	Material, color and electrical specifications
<input type="checkbox"/>	List of sign face area of all existing signs
<input type="checkbox"/>	All applications must include a Site Plan
<input type="checkbox"/>	PDF submissions are required email: permits@fbgtx.org

Definition:

Sign – any letters, figures, symbols, trademarks or devices designed to inform people or attract the attention of persons or to an individual firm, profession, business, commodity or service and which is recognizable from any public right-of-way, and which is more specifically defined in the City of Fredericksburg Sign Ordinance – Chapter 29.

Disclaimer:

No person shall erect, construct, alter, repair or relocate a sign without first obtaining a permit from the City of Fredericksburg. Each application shall be accompanied by such drawings, descriptions, and specifications as are deemed necessary by the City of Fredericksburg. After a sign permit has been issued by the City, it shall be unlawful to change, modify, alter, or otherwise deviate from the terms and conditions of said sign permit without prior approvals by Code Enforcement.
